UNISON 2017 National Retired Members Conference

Llandudno 10/11 Oct 2017

Scottish Branches were well represented at UNISON's 2017 National Retired Members Conference - held in Llandudno on 10th/11th October.

We had over 40 delegates from 27 branches and 3 'regional' representatives - Regional RM Secretary Marie Macrae, Rose Jackson who sits on the National RM Committee and Bob Revie who is our rep on the Standing Orders Committee.

Scotland has a major influence in much of the Union's Retired Members matters.

All of our speakers were well-received and all but one of the motions we were supporting were approved.

UNISON's National Retired Members Conference is one of the largest Union Conferences in the UK. Taken as a single entity, UNISON's RM membership (170,000+ strong) would be the 7th largest Trade Union in the UK. Llandudno Conference had nearly 600 delegates - with over 40 from Scotland.

UNISON Brexit Update

This workshop was by far the best attended. Fearing a pro-Brexit rant or two which would have made me angry I wasn't too sure of attending, but I'm glad I did ...

Alison Roche - Unison Lead Officer on Brexit - summarised UNISON's involvement in the ongoing negotiations and outlined the Union's key priorities.

Jane Thomas - "Repeal the Bill" Coordinator - was the most outspoken of the 3 speakers. As her title suggests she is all in favour of forcing the Government to reverse its decision to

trigger Article 50. The Repeal the Bill movement argues that original 'Leave' decision was flawed by false information and evidence suggests that many Leave voters now would vote to remain if given a 2nd Referendum.

Kalba Meadows - "UK Citizens in the EU" outlined the concerns of UK Citizens who are resident in the EU - and their current insecurity. Kalba and her family live and work in France. Their have fears for example on health cover and the certainty of being able to continue to living abroad if no suitable 'soft' Brexit Agreement is negotiated.

The WASPI Campaign

The Government's proposed pension changes will badly affect women in a narrow age band - so WASPI was a real 'hot topic' for Conference!

The workshop and Conference debates urged Branches to push for a change in the legislation to make sure that a narrow age-band of women are not unduly-affected by the Government's proposed changes in qualification dates.

Delegates from the North Wales Region lobbied on WASPI throughout Conference - even by

totally hijacking one which nothing at all to do with WASPI!

Funeral Poverty

This workshop was well-attended. It highlighted the escalating costs of funerals - averaging £4K to 6K (depending on region) and stressed the need for national regulation of the funeral industry. Funeral costs are a developing national scandal. Families are being forced into debt to cover exorbitant cost which are too often presented by the funeral industry when relatives are in shock and mourning - and unable to make proper judgments on costs.

No doubt the vast majority of funeral directors are caring and professional to the hilt. However, various speakers gave examples of overcharging

Our union has many special people, who dedicate their lives to their friends, their communities and our movement. Lillie McNaughton was one of those people.

A brilliant trade union activist - active remember in the union until her 80s, Lillie was for many years Police Convenor in the Strathclyde Regional Branch, and later an active member of the Strathclyde Police and Fire Branch. President gave

Lillie spoke with passion on the same issue at subsequent Conferences - even when she was over 80 years old. She was made an 'honorary' UNISON Scotland Young Member as a result.

Scotland at Conference

All but one of the motions or amendments which were supported by Scottish Region were carried. Among the other motions, worth mention were

Funeral Poverty

This pinpointed much of the information that had been given out in Tuesday's workshop session - and incidentally at our Scottish Regional RM Conference March. The motion called for national regulation of the funeral industry.

Investing Pension Funds in Care Homes

This called for the ethical investment of public sector pension funds in building new care homes for senior citizens, to be run and controlled by Local Authorities.

Bus Passes

This drew attention to eligibility for a free bus pass being 60 in Scotland, Wales, Northern Ireland and London but at the (ever-rising) female State Pension Age in the rest of England. Conference agreed that the eligibility age should be 60 throughout the UK.

Jim Friedland from Shetland spoke well in this debate, urging the introduction of a UK Universal bus pass, which could allow RM travel thoughout the UK.

Recruiting Care Workers

This called for the recruitment of care workers into the union to be prioritised, and urged the use of Retired members in the recruitment campaign.

Branch had 2 motions on the agenda - both carried. Sue Chalmers moved the motion on an "Advocacy Service for residents in Care Homes for the Elderly". She pointed out that no independent advocacy system exists vulnerable care home residents and that the Care Quality Commission/ Care

Inspectorate


Jim Friedland from Shetland

Christina emphasised that UNISON has won the public argument that public service workers deserved a rise - but she warned that the problem of a gap in funding remained.

The Government may attempt to cherrypick some public service workers (Police, Fire and Nurses) ahead of others in its effort to be seen to be

rewarding public service workers as a whole.

Christina (pictured right) scorned hints that the Government aims to end the pay cap that has held down public service pay for seven years, by

noting: "We haven't seen the colour of any money yet ..."

If workers find themselves being offered amounts that are only symbolically above the cap - for instance, 1.1% - "there'll be no champagne corks popping".

"Retired Members Sections should be a major part of the campaigning arm of the Union - getting out and leafleting workplaces, lobbying council meetings and getting active in local and national politics" said John.
