### **Public Works Loan Board Rate**

No one who wants to see investment in public services is going to throw their hats in the air at the PWLB raising their interest rates. That doesn't mean that isn't still the best mechanism for public bodies to fund the building or refurbishment of facilities and infrastructure. The alternatives put in place by successive occupants of Bute House (PFI/PPP/NPD and now MIM) – are all more expensive than borrowing via the PWLB. This can be seen in Audit Scotland's recent report into Local Authority finance. Despite being only 17% of overall council debt – such schemes account for 30% of interest payments.

Councils and others at the sharp end may well feel they condemn the UK Government for 'profiteering at the expense of tax payers. Parliamentarians having pushed public bodies into even more expensive options should be perhaps be reflecting on how they cut the commercial interest rates being paid on the revenue financed schemes they brought in down to the PWLB rates that they find so objectionable.



### **Too much of Scotland's FOI law is not fit for purpose**

UNISON Scotland and Campaign for Freedom of Information presented a [new report](#) at the Scottish Parliament saying that too much of Scottish Freedom of Information law is not fit for purpose.

## Briefing 111: Early Learning and Childcare: outdoor learning

The Scottish government has now published its [guide](#) for creating outdoor play experiences in early learning and childcare. The government is committed to including increased opportunities for outdoor play in its early learning and childcare expansion programme. The guide is also aimed at schools and out of school care services. It is likely that the guide will mean that employers will move ahead with plans to expand outdoor learning. This may lead to ELC staff and other UNISON members being asked to spend increased time working outdoors. It is therefore likely that branches will be working with employers across education teams regarding changes to members work.
